

## **Description**

The STEVAL-MKI168V1 is an adapter board designed to facilitate the evaluation of the IIS2DH 3-axis accelerometer for industrial applications in the MEMS product family. The board offers an effective solution for fast system prototyping and device evaluation directly within the user's application.

The STEVAL-MKI168V1 can be plugged into a standard DIL24 socket. The adapter provides the complete IIS2DH pinout and comes ready to use with the required decoupling capacitors on the  $V_{DD}$  power supply line.


This adapter is supported by the STEVAL-MKI109D evaluation platform, which includes a high-performance 32-bit microcontroller functioning as a bridge between the sensor and a PC, on which it is possible to use the downloadable MEMS Studio graphical user interface or dedicated software routines for customized applications.
