Figure 1. STDES-8PIOLM4P circuit schematic (1 of 12)





Figure 2. STDES-8PIOLM4P circuit schematic (2 of 12)




Figure 5. STDES-8PIOLM4P circuit schematic (5 of 12)

The figure contains two detailed circuit schematics for signal conditioning.
Top Schematic (U22): This circuit takes an input signal (IN_TX_E) through a 40kΩ resistor (R155) and a 10kΩ resistor (R156) to a 100nF/50V capacitor (C106). The signal then passes through a 10kΩ resistor (R157) and a 10kΩ resistor (R158) to a 100nF/50V capacitor (C103). The output of this stage is connected to the input of the U22 op-amp. The op-amp is configured with VDD and VDE pins. The output of the op-amp is connected to the input of the U22 op-amp. The output of the op-amp is connected to the input of the U22 op-amp. Bottom Schematic (U24): This circuit is similar to the top one but uses different component values. It includes a 40kΩ resistor (R167), a 10kΩ resistor (R168), a 100nF/50V capacitor (C113), a 10kΩ resistor (R169), a 100nF/50V capacitor (C110), a 10kΩ resistor (R170), a 10kΩ resistor (R171), a 100nF/50V capacitor (C111), and a 10kΩ resistor (R172).
