


Figure 1. STDES-PFCBIDIR schematic diagram - control board







Figure 4. STDES-PFCBIDIR schematic diagram - power board: aux power DC-DC





Figure 6. STDES-PFCBIDIR schematic diagram - power board: connector





Figure 8. STDES-PFCBIDIR schematic diagram - power board: DC voltage sensing





Figure 11. STDES-PFCBIDIR schematic diagram - power board: power section




Figure 13. STDES-PFCBIDIR schematic diagram - power board: temp control
