Figure 1. STDES-VRECTFD circuit schematic - power board (1 of 11)






Figure 2. STDES-VRECTFD circuit schematic - power board (2 of 11)




Figure 3. STDES-VRECTFD circuit schematic - power board (3 of 11)





Figure 4. STDES-VRECTFD circuit schematic - power board (4 of 11)

Figure 5. STDES-VRECTFD circuit schematic - power board (5 of 11)






Figure 6. STDES-VRECTFD circuit schematic - power board (6 of 11)





Figure 7. STDES-VRECTFD circuit schematic - power board (7 of 11)




Figure 9. STDES-VRECTFD circuit schematic - power board (9 of 11)




Figure 10. STDES-VRECTFD circuit schematic - power board (10 of 11)




Figure 11. STDES-VRECTFD circuit schematic - power board (11 of 11)




Figure 12. STDES-VRECTFD circuit schematic - control board

#### **LICENSE**

STMicroelectronics ("ST") grants You the right to use the enclosed Evaluation Board offering limited features only to evaluate and test ST products solely for Your evaluation and testing purposes in a research and development setting. The Evaluation Board shall not be, in any case, directly or indirectly assembled as a part in any production of Yours as it is solely developed to serve evaluation purposes and has no direct function and is not a finished product.
