




Figure 2. STEVAL-CTM015A1 circuit schematic (2 of 12)







Figure 3. STEVAL-CTM015A1 circuit schematic (3 of 12)













Figure 5. STEVAL-CTM015A1 circuit schematic (5 of 12)

Figure 6. STEVAL-CTM015A1 circuit schematic (6 of 12)






# Stator windings Current Sensing - ICS










Figure 10. STEVAL-CTM015A1 circuit schematic (10 of 12)

Figure 11. STEVAL-CTM015A1 circuit schematic (11 of 12)





Figure 12. STEVAL-CTM015A1 circuit schematic (12 of 12)

Figure 13. STEVAL-CTM015A2 circuit schematic (1 of 3)




Figure 14. STEVAL-CTM015A2 circuit schematic (2 of 3)





Figure 15. STEVAL-CTM015A2 circuit schematic (3 of 3)

#### **LICENSE**
