






Figure 1. STEVAL-FSM01M1 circuit schematics (1 of 6)














Figure 4. STEVAL-FSM01M1 circuit schematics (4 of 6)









Figure 5. STEVAL-FSM01M1 circuit schematics (5 of 6)





Figure 6. STEVAL-FSM01M1 circuit schematics (6 of 6)

LICENSE

STMicroelectronics ("ST") grants You the right to use the enclosed Evaluation Board offering limited features only to evaluate and test ST products solely for Your evaluation and testing purposes in a research and development setting. The Evaluation Board shall not be, in any case, directly or indirectly assembled as a part in any production of Yours as it is solely developed to serve evaluation purposes and has no direct function and is not a finished product. If software and/or firmware is accompanied by a separate end user license agreement ("EULA"), then such software and/or firmware shall be governed by such EULA.

EVALUATION BOARD STATUS
